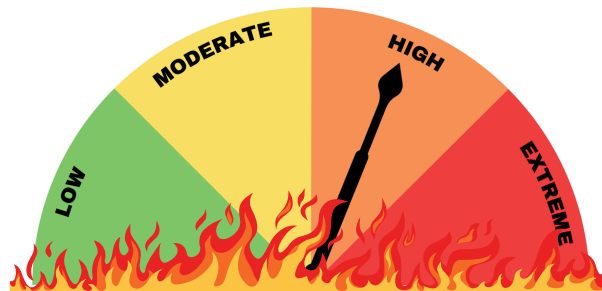

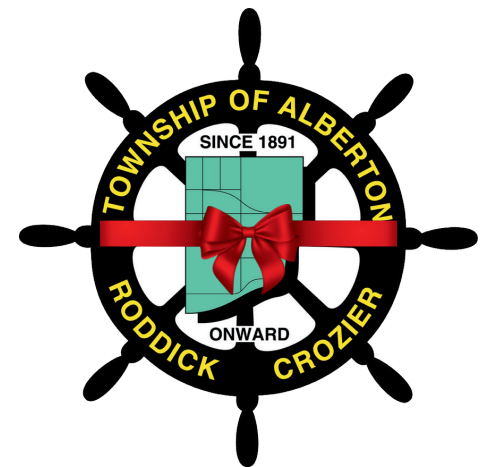

# VIEW & PAY YOUR PROPERTY TAXES ONLINE!

Visit our website [www.alberton.ca](http://www.alberton.ca) to register for eBills, then follow the onscreen instructions to view your property tax bill online!

Avoid lost or stolen cheques by using your banks online bill payment feature. Customers of CIBC, Credit Union, TD, and RBC can now take advantage of this option at no additional cost. Your tax roll number is your account number. When setting up your bill payment, your bank will want the last digits of your account number. For example, if your bank requests a 12-digit account number, you will enter the last 12-digits of your roll number as shown in **red** below.

Roll# 59-11-000-**000-12345-0000**

Customers of other financial institutions wishing to pay their taxes electronically may continue to send e-transfers to [alberton@jam21.net](mailto:alberton@jam21.net)
